The OPA Legislative Defense Fund paves the way for another successful year of advocacy!

In 2014, OPA launched the Legislative Defense Fund (LDF) at the request of long-time member Bob Mabe, an independent pharmacy owner seeking to help OPA boost its advocacy efforts for pharmacists.

Since the LDF's inception, in just over two years OPA has:

- expanded pharmacist immunization authority
- ushered in nationally heralded drug pricing transparency reforms
- created audit standards and protections for pharmacies
- instituted pharmacy benefit manager (PBM) licensure and regulatory requirements
- allowed long-acting drug administration authority for pharmacists
- allowed pharmacist naloxone dispensing without a prescription
- pushed for great fairness and objectivity with Medicaid reimbursements
- gained full prescriptive authority for pharmacists operating in collaborative agreements.

Unlike a Political Action Committee (PAC) fund, where personal funds are given directly to political campaigns, both personal and corporate funds are accepted by the OPA LDF to enhance our government affairs endeavors, and there are no limits on the amount you can give. 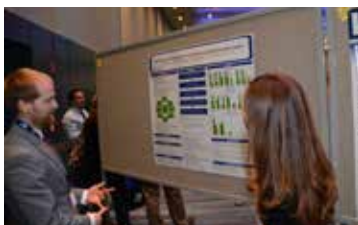

What does the future hold?

Throughout school, student pharmacists are always looking toward a singular deadline: Graduation. As student pharmacists begin to make the last lap through clinical rotations, the clock begins to tick with the question, "What are you going to do post-graduation?" A few students have the answer before pharmacy school, but there are more students left asking themselves what they really want to do. Many students pursue pharmacy residencies for additional post-graduate training in areas of interest to them, and others join the bustling workforce. That leaves a few "lost" students. Perhaps they are interested in a residency, but not fully sold it's the right path for them, or their dream career path is too competitive to jump into right away. Where does that leave those students?

Getting from point A to point B is often not a single journey, but one that involves elbow rubbing. Staying active in pharmacy organizations post-graduation will help many students make a smoother transition from student to practitioner. One such group is our very own New Practitioner eXperience (NPX). This group is made up of practitioners who are 7 years or less post-pharmacy school graduation, and provide guidance from recent personal experience. My dad has always told me that a job is only 50% about what you know and 50% about who you know. That PharmD degree gives you a large chunk of the first 50%, so get involved and round out the last 50% with NPX.

NPX offers opportunities to get involved on a professional level with events at the Annual Conference, with committee meetings, and through their own newsletter. The NPX group also gets together to socialize with events such as Columbus Blue Jackets hockey games, and a financial Q & A education session. While passing on wisdom to student pharmacists for the road ahead, NPX provides an avenue to discuss current topics affecting new practitioners. You don't even have to sign up. As an OPA member out of school 7 or fewer years, you are already enrolled. Take advantage of this opportunity.
